The tender form can be obtained from the college office on payment of **Rs. 100/-** in the cash counter. Bidder may also download the tender Documents from the web site **www.lncpe.gov.in**. It is clarified that the downloading of tender documents will be free of cost; however a sum of **Rs.100/-** being the cost of the tender document to be remitted to the college office and receipt attached or enclose **DD for Rs. 100/-** along with the tender documents. The tender should contain the rates quoted for the Annual subscription of Internet connection. Terms and Conditions

1. The Internet connection is through optical fiber cable with 4 Mbps (1:1) connectivity.
2. The EMD of Rs. 1000/- can be remitted in the college office and receipt attached with the tender. The EMD is also accepted as DD drawn in favour of Principal LNCPE payable at Trivandrum.
3. The rate should be quoted in the attached prescribed format inclusive of all taxes for a period of one year.
4. The sealed cover containing the tender should also enclosed with the cash receipt of tender cost / EMD or the Demand Draft for the same.
5. The provider will assure the availability and stability of the specified bandwidth throughout the duration of the agreement.
6. The work should be completed as per the specifications mentioned in the quotations and work order.
7. The provider shall ensure 99% uptime (4 Mbps 1:1 connectivity) on bandwidth to LNCPE throughout the period in which the connection exists.
8. The payment will be made only after the execution of agreement and the Internet connection made functional as per work order and specifications and satisfactory completion of all the required initial works to commence the annual subscription.
9. Principal SAI-LNCPE reserves the right to reject or accept any quotation on part or in whole without assigning any reasons thereof at any time.
10. If any service / connectivity related complaint was not rectified by the concerned provider after the intimation by LNCPE, LNCPE can opt for termination of service by giving a 30 days' notice in writing to the concerned provider.
11. Income tax will be recovered at source as per the rate applicable.
12. 10% of the quoted amount will be retained as security deposit and it will be refunded only on successful completion of the contract and against no dues.
13. The Bidder must visit the site and ensure their compatibility and requirements.
